

Croatia Tourist Visa Checklist

- **Original Passport with old passport :**
 - **Note :** Passport should be valid minimum 06 months from the date of travel, Passport has been issued within 10 years and validity must not exceed 10 years, No hand written passports will be accepted and at least 2 blank pages.
- **Visa Application Form :**
- **2 recent photograph each :**
 - (35*45 mm size, white background, matt finished & 80% face image, without specs & not used in previous visa)
- **Evidence of Financial Documents :**
 - Last 06 months Personal Updated Bank Statement with bank sign and stamp on each page with sufficient balance
 - Last 03 years Personal Income Tax Returns Acknowledgement Page only
- **If applicant is Employee :**
 - Last 06 months Pay Slips
 - Original Leave Sanctioned letter should address to the consulate/Embassy
- **If applicant is Self Employed :**
 - Business letterhead with Sign & Stamp
 - Business Registration (For Proprietor – Company Registration & GST Certificate, For Partner - Partnership Deed, For Director - Memorandum of Association)
 - Last 03 years Income Tax Return Acknowledgement Page only
 - Last 06 months Updated Bank Statement with bank sign and stamp on each page
- **If applicant is Retired :**
 - Retirement letter from Employer
 - Pension Payment Order OR Pension passbook.
- **If applicant is Student :**
 - Letter from school / university for grant of leave
 - ID Card Copy of School / College
- **If visiting as a Tourist :**
 - Hotel Confirmation Voucher (From Supplier OR Directly from Hotel)
 - Confirmed Return Ticket
 - Day Wise Tour Itinerary
- **Overseas Medical Insurance Policy :**
 - Minimum coverage of 30,000 Euro per person, the insurance has to cover the entire stay in Schengen territory, minimum 15 days insurance is mandatory from the travel date

Important Notice :

- Please pay attention that pursuant to the Government's Decision, the Republic of Croatia applies the Decision No 565/2014/EU according to which all visitor's holders of valid Schengen documents, as well as national visas and residence permits of Bulgaria, Cyprus, and Romania do not require an additional (Croatian) visa for Croatia.
- Therefore, visitors who are holders of:
- Uniform visa (C) for two or multiple entries, valid for all Schengen Area Member States

Note :

- All Documents required in A4 Size Paper and English Only

- No documents will be return back by Embassy/Consulate after visa process.
- Must declare rejection if rejected in any country in last 10 years and mention rejection year and category of visa of Rejected country.
- All applicants have to pay visa fees, VFS charge & courier charge in cash at local VFS-centre.
- Please note that you may be required to come for a personal interview with the visa officer at the Embassy of the Croatia prior to a decision being made on your application.
